C.A.R. has worked tirelessly to mandate Remarks- Listing Content and Fair Housing (Section 12.5.2 in your Fresno MLS Rules) a rule that ensures all listing information, including remarks is in Compliance with Fair Housing Laws. Your Rapattoni MLS system will now alert you in the event an unacceptable word or phrase is entered into your listing information.


